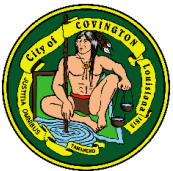

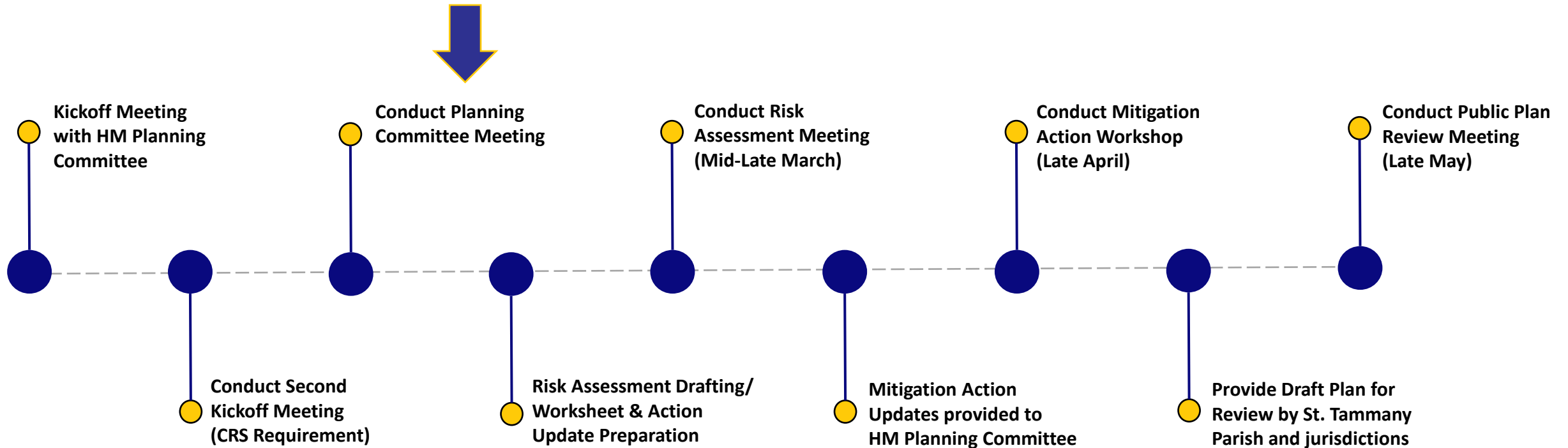


HM Plan Update Requirements

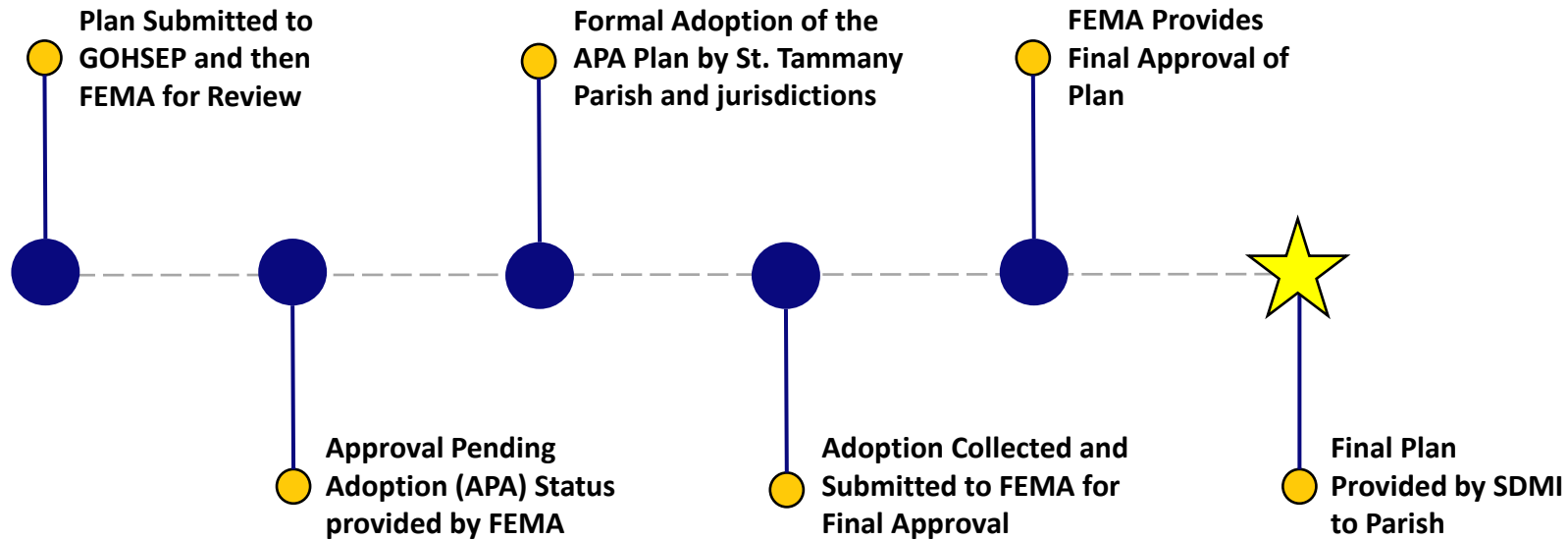
- The plan must be updated every 5 years
 - STP's plan was last updated in 2020.
- Re-assess hazard identification and risk assessment
 - Hazards incorporated in the 2025 plan will be based on NRI classifications
- Incorporate additional local planning efforts;
- Report mitigation strategy (projects) progress and discuss adjustments;
- **Must have a robust planning committee**
 - Include academia, private business/industry, and non-profit groups as stakeholders.
 - Very important for meeting CRS requirements

Planning Committee Expectations

- Parish will serve as the main liaison/POC throughout the planning process
- Parish and community representatives **MUST** show active participation in the planning process by the following:
 - Have representation at meetings;
 - Report to community and gather feedback from appropriate agencies;

 - Identifying and updating specific mitigation actions (projects);
 - Adopt the final plan.



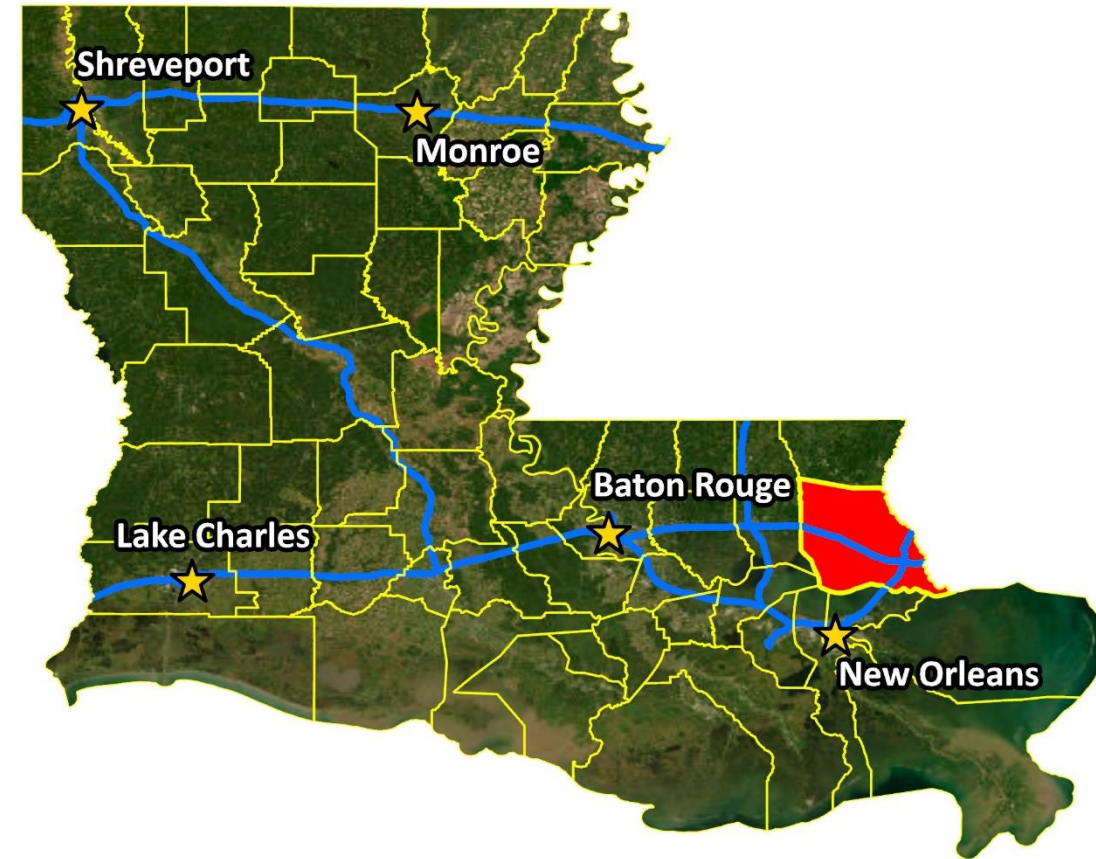

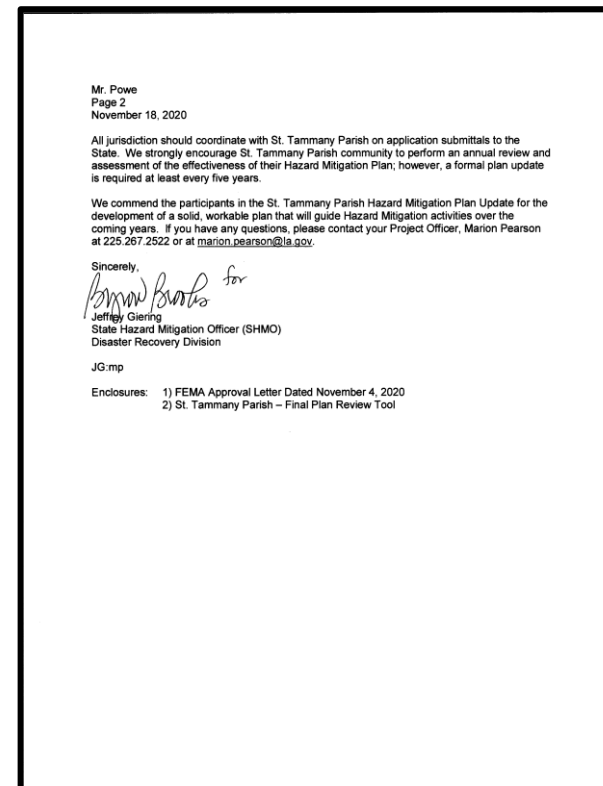
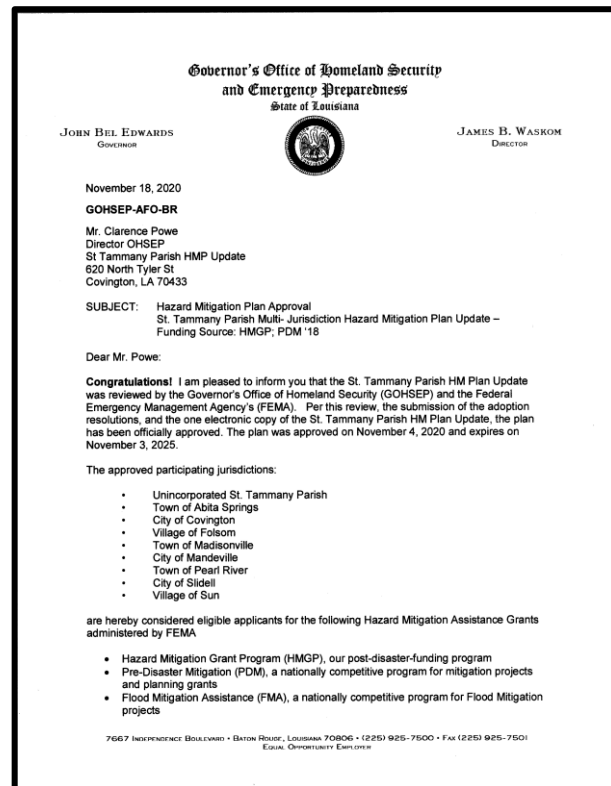
Appendix C: Critical Facilities

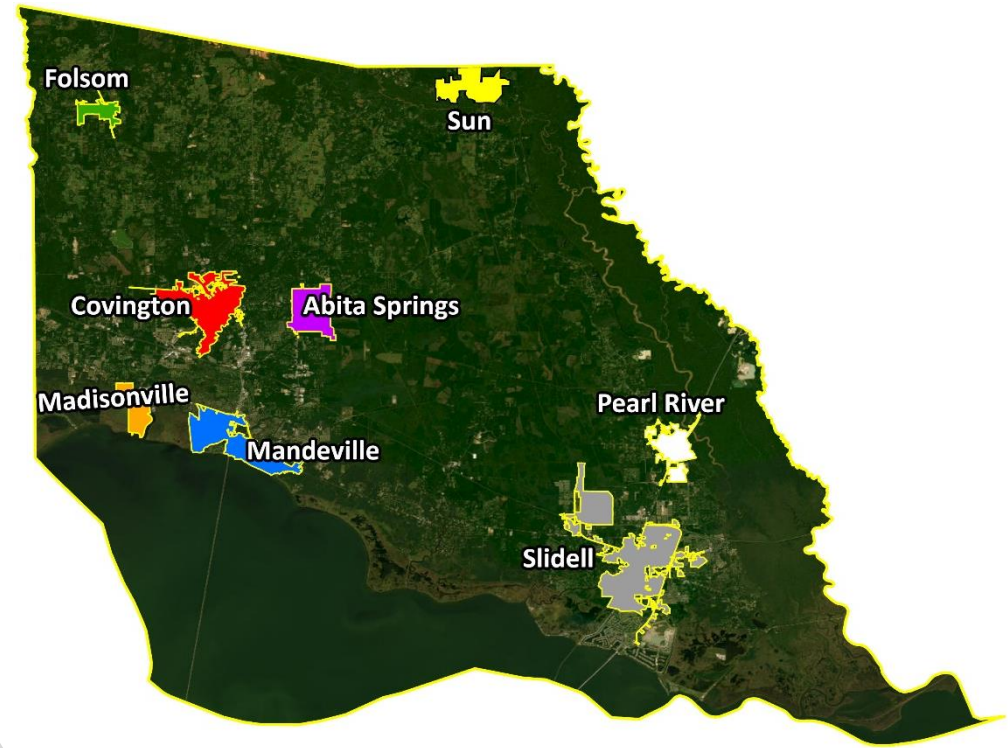
- Parish council resolution must be adopted, signed, and placed into the final planning document

- Some of the steps that are included in the FMP will be accomplished the hazard mitigation planning process.
 - Risk Assessment Meeting (Steps 4-6)
 - Mitigation Action Workshop (Steps 7-8)
- Other steps will need to be addressed by participating communities

Survey Trends So Far...

- As of February 17, 2025...
 - 86 responses collected
 - Flooding, Tropical Cyclones and Tornadoes are the hazards of greatest concern to respondents.
 - Almost 50% of residents place more trust in their local government for hazard information than in eleven other external sources.
 - Roughly 70% of respondents reported being unaware that the hazard mitigation plan requires an update every five years.
